


8 **NOTICE OF FILING CASH DEPOSIT**

17 temporary injunction shall be dissolved in whole or in part.

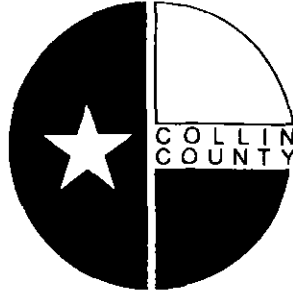

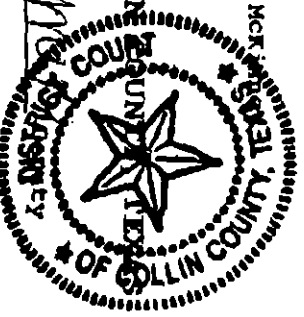
